TERMS AND CONDITIONS:

I AGREE TO PARTICIPATE IN THE BARCALDINE REGIONAL COUNCIL'S 'MADBAG MINI TRIATHLON' UNDERSTANDING THE FOLLOWING TERMS AND CONDITIONS:

1. By participating in this event, I accept all risks necessarily flowing from my participation, which could result in loss of life, any injury or permanent injury. Accordingly, I release all people associated with the conduct of these events from, and will indemnify them against, all liability (including liability for their negligence) for all injury, loss or damage arising out of or connected with my participation in this events. For clarification, the people released include event organisers, promoters, sponsors, all stallholders and all their respective directors, officers, employees, agents, contractors and volunteers including event medical and paramedical personnel. This release and indemnity continues forever and binds my heirs, executors, personal representatives and assigns.
2. I acknowledge that events involve the real risk of serious injury, or risk of death from various causes including over-exertion, equipment failure, dehydration, accidents with or without other competitors, spectators and road users, the course and weather conditions, just to name a few.
3. I understand that I should not participate in events unless I have prepared appropriately and am medically fit.
4. I understand that compulsory insurance cover affected for participants in this events and training does not cover me for all injury, loss or damages sustained by me.
5. The safety precautions undertaken by event organisers (such as course supervision, race safety briefings, visual bicycle and visual helmet safety checks) are a service to me and other competitors but are not a guarantee of safety.
6. I acknowledge and accept that I am solely responsible for my participation and the participation and supervision of my child.
7. I agree to abide by all the Rules of Triathlon Australia, which relate, in part, to safe and fair sporting practices.
8. I agree to abide by state traffic rules.
9. I understand my child or I may be photographed during the event and used in public media.
10. I understand that the course will close 2-3 hours (course specific) after the commencement of the race and that should I continue after that time, it will be without the full assistance of race organisers.
11. I acknowledge that my entry fee is non-refundable due to inability to attend.
12. I hereby acknowledge that I have sole responsibility for my personal possessions and athletic equipment during the race and its related activities and functions.
13. If I am issued with a timing chip, I understanding that it is on loan and I am responsible for the safe return of this chip at finish (or early withdrawal) of the event. If not returned a charge of \$50.00 applies.
14. I hereby consent to receive such medical treatment that may be deemed advisable in the event of injury, accident and/or illness during the race.
