# **Community Project Grant**

For Community Grants above a combined value of \$1500.00 will now be required to submit an application in one of the below Grant Rounds.

### **Preparing your application**

## Who Can Apply

- Be an incorporated not-for-profit community organisation, or have an auspice arrangement with an incorporated, not-for-profit organisation.
- Be applying for a project or event which directly benefits the Barcaldine region
- Be able to demonstrate current and ongoing financial viability.
- Owe no debt to Council, (unless an agreed payment arrangement with Council is satisfactorily being met).
- Have appropriate insurances; and
- Where relevant have successfully acquitted any previous Council grants

# **Ineligible Organisations**

- Local, State or Federal Government agencies/departments
- Commercial businesses and enterprises
- Foreign entities, such as a charity formed or incorporated outside of Australia
- Political organisations

# Following Items will not be considered for funding:

- Core education or curricula activities
- Payment of debt
- Items or services purchased or any project activities delivered prior to notification of the grant outcome
- Prize Money
- Trophies
- International Travel Costs
- Vehicles and related costs
- Alcohol
- Any goods for resale (such as merchandise)
- Any clothing that will become the property of individuals

#### Assessment Criteria

Barcaldine Regional Council Community Grants are competitively assessed grant programs. Even though an application may meet the eligibility criteria, success will depend on the number of applications received, how well the project aligns with Council's goals and outcomes, the grant priorities, and available funds.

Eligible applications are assessed against the following criteria:

- Project demonstrates strong community or individual benefit
- Project aligns with Councils corporate objectives and strategies
- Project contributes to economic development, tourism and livability
- Attempts have been made to raise money from other sources
- Budget overview has been provided for the project
- Has the applicant previously applied for grant funding in other rounds for the financial year.

## Outcome of Application

### Successful applicants will be:

- Notified in writing of outcome
- Responsible for obtaining all appropriate permits, approvals, licences, insurances etc. to undertake the project

### Unsuccessful applications will be:

- Notified in writing of unsuccessful outcome
- If the applicant meets the eligibility criteria, be able to reapply in further funding rounds in the same financial year

## By submitting an application, the applicant consents to council:

- Advertising events/projects that have been successfully funded by council (i.e. media release, social media); and
- Advertising successful recipient details on council's website (including but not limited to, project description, name of recipient, amount funded).

# **Supporting Documents**

- Relevant Public Liability Insurance
- Written confirmation from the auspicing organisation.
- Approval from landholder where the project or initiative is being held
- Include cofounding contributions or other external funding.
- A copy of the organisations most recent bank statement
- Evidence of the project (quotes, facility bookings, ect)
